Section 1: Summary of Major Events

Contractor and Policy Update

There were no policy updates during January 2023.

Locality Update

The usTLD Locality space is monitored by Registry Services to ensure adherence to usTLD policies and procedures. We now have 12,500 total usTLD Locality names. Of those, Registry Services manages 9,386 as the Delegated Manager, and the remaining 3,110 are covered by external Delegated Manager Agreements.

There was one Delegated Manager agreement executed this month.

Technical and Operational Update

There were no operational changes during January 2023.

Marketing Update

Kicked off 2023 with a new set of creative to rotate into paid advertising efforts. A total of six new assets were developed for promotion on Facebook, Instagram and partner channels. Video was also updated to swap out photography with new and relevant images to continue engaging the small business audience. Paid marketing efforts launched across social and YouTube platforms based on top performing audience targets. January results are highlighted below:

Impressions - 313K Conversion Rate - 7.7%

Content for January includes a new article published to the about.us website, ""5 Marketing Resolutions to Make in 2023"" https://www.about.us/blog/5-marketing-resolutions-to-make-in-2023. This article includes digital specific action items from SEO to testing new trends. The target audience is small businesses owners researching new marketing tactics for the New Year and touches on the importance of a relevant website presence. Search engine optimization tactics continue to support quality website visits to about.us. Overall organic traffic is flat to last year, but session duration has doubled for organic website visits, moving from twenty seconds in 2022 to forty seconds in 2023 and just over four pageviews per session (compared to 1.4 in 2022).

A key element to the .US marketing strategy continues to be connecting with new .US brand ambassadors and showcasing their brand and website to the small business audience. In January, our social media highlighted four new .US businesses including:



- americanclassictattoo.us: An artist-owned and operated tattoo shop with two locations in Virginia.

- carepool.us: Rideshare+ model provides convenient, reliable, and fully accessible transportation for aging adults and people with disabilities.

- ameriloans.us: Ameriloans Mortgage carefully guides customers through the home loan process. - advancedmarinegroup.us: A complete yacht management package so that owners can relax knowing that someone is watching their back.

Ongoing partnerships with Startup Weekend and Major League Hacking continued into 2023, along with activation of student organizations LeanGap and the Conrad Challenge. Highlights are included below.

Startup Weekend

Lead partner of Startup Weekend, providing domain names to startup founders at thousands of hackathon events around the world. Startup Weekend supports the startup, entrepreneur and local coding communities worldwide through a 54-hour, 3-day pitch event for launching new companies.

Major League Hacking is the official student hackathon league. Participants are all undergraduate students concentrating on computer science, engineering and coding. Each year, they power over 200 weekend-long invention competitions that inspire innovation, cultivate communities and teach computer science skills to more than 65,000 students around the world.

Registry Services, LLC is a proud sponsor of the program offering attendees a domain and website bundle scholarship to use to launch their project throughout the weekend. .US is included as a featured domain option for redemption and each event has a "Best Domain" category winner that's awarded a prize pack for their efforts.

New registrations in January 2023 were 2.32% higher than January 2022. Names under management in January 2023 were 8.02% higher than January 2022. The renewal rate in November 2022 (most current data available due to 45-day grace period) was lower year over year at 57.09% vs. 73.50% in November 2021.
