



usTLD REGISTRATION DATA REQUEST TERMS AND CONDITIONS

Registry Services, LLC, the Administrator for the usTLD, has collected registration data for the WHOIS database and Registration Data Directory Service through a .US-Accredited Registrar. The information is provided to you for informational purposes only and is designed to assist persons in determining contents of a domain name registration record in the registry database.

You must have a legitimate interest in the information being requested that is not overridden by the interests, fundamental rights, and privacy of any individual to whom this information relates. In your request, you must specify the legitimate use for which the data is being requested. Data will be provided only to legitimate requesters. The usTLD Administrator will determine whether or not the specified use is legitimate and proportionate, and we reserve the right to request further information or evidence to establish legitimacy.

A copy of your request will be sent to you at the email address provided. Your request will be reviewed and the determination of that review will be communicated to you via the email address provided. We may contact you to request more information to support your request.

By submitting a request, you warrant that:

- You are authorized to make the request;
- You have a legitimate interest in accessing and processing registration data that is not overridden by the interests, fundamental rights, and privacy of any individual to whom this information relates;
- You will not use this service or any information provided by us in a way that is inconsistent with any applicable law, rule, regulation or statute or any policy issued by Registry Services, LLC;
- You will take reasonable precautions to protect any information provided by us from loss, misuse, alteration, or unauthorized access or disclosure;
- You will not disclose, publish, or otherwise use any information provided by us for any purpose other than that which is specified in your request for such information; and
- You agree to abide by the terms of the Data Protection Agreement and [usTLD Privacy Policy](#).

Registry Services, LLC makes information available to you "as is" and does not guarantee its accuracy. By submitting a registration data request query, you agree that you will use this data only for lawful purposes and that, under no circumstances will you use this data:

- (1) to allow, enable, or otherwise support the transmission of mass unsolicited, commercial advertising or solicitations via direct mail, electronic mail, or by telephone;
- (2) in contravention of any applicable data and privacy protection laws;
- (3) for targeted advertising in any possible way;
- (4) to enable high volume, automated, electronic processes that apply to the registry (or its systems); or
- (5) in contravention of any applicable data and privacy protection acts.

Compilation, repackaging, dissemination, or other use of the registration data in its entirety, or of a substantial portion thereof, is not allowed without our prior written permission.

NOTE: FAILURE TO LOCATE A RECORD IN THE WHOIS DATABASE IS NOT INDICATIVE OF THE AVAILABILITY OF A DOMAIN NAME.

Information that you provide as part of, or in support of, the request will be logged and stored by us indefinitely. This information may be made available to the usTLD Administrator, data protection authorities, data subjects, or law enforcement as required.
